Portpatrick Community Development Trust was formed in March 2019 to look at opportunities around activities for delivering improvements to the local community. Its potential role is wide and includes the provision of social and community activities or facilities, environmental, heritage and cultural improvements, youth development and supporting activities for local people, groups and businesses.

Full members

- are ordinarily resident in the defined community of Portpatrick and environs, (*see web site for list of postcodes*)
- are registered to vote at a local government election in a polling district that includes the defined community.
- support the objectives and activities of the company.

Associate Members

Associate membership is open to individuals who are not ordinarily resident in the Community, but support the objects and activities of the company, and to organisations and businesses that support the objects and activities of the company.

Junior Membership

Junior members are individuals aged between 12 and 15 who support the objects and activities of the Company. (Junior members do not need to be resident in the Community).

Annual Subscription

There is annual membership subscription payable by Members and Associate members; the current amount of the annual membership subscription is £5.00. (Five Pounds). Subscriptions are payable on admittance to membership or for existing members on the 1st April each year. This first year runs from 1st April 2019 until 1st April 2020.
