# **About the Development Plan**

The plan has been developed by Portpatrick Community Development Trust to support our Stage 2 application in consideration of the Community Asset Transfer of Portpatrick Village Hall. However it is not all about the Village Hall.

Our proposals are for the development of a vibrant and active Community Hub delivering a wide range of real and lasting Community Benefits, bringing together elements of:



- Arts and Culture
- Sport and Recreation
- Health and Well-being
- History and Heritage
- Economic Development

# The Opportunity

The business plan is about developing a **successful** and **sustainable** Community Hub, a place where groups can come together, a facility for **all community groups** and a vehicle for delivering value and empowering community activity. Our aim is to provide the opportunity to work together to repair, renew and regenerate our community.

## **Our Vision**

Our vision has evolved through the market research and consultation with potential partner organisations, but we are not at the end of the road, this is just the start of our journey, we will continue to listen, explore and consult and seek ways to deliver a fully inclusive and successful Community Hub that meets the needs of all of our community. We have looked at successful

models elsewhere and this has shaped what we believe can be achieved in Portpatrick.

# Some Highlights from the Plan

#### **Arts and Culture**

Portpatrick is under represented in regional events like Spring Fling, D&G Arts and D&G live as well as in the rural touring activities of national bodies like Scottish Youth Theatre and RSNO. We have agreed to work alongside other local Trusts and Groups on a joined up approach, giving us a stronger voice to secure more for the Village.

#### **Sports and Recreation**

Environmental Improvement

We have discussed options with various existing community groups offering a range of activities including Country Dancing, Tennis, Badminton, Netball, Trampoline, Zumba, Silver Exercise, Jive, Line Dancing and adult Tap classes. We recognise that it is important that any initiative to introduce new classes or recreation activities is not to the detriment of existing groups

#### **Health and Well-Being**

The demographics of Portpatrick present particular challenges as the population of Portpatrick is on average older. We will be working with Dumfries and Galloway Health and Social Care Partnership. D&GHSCP is seeking to create, deliver and sustain new models of health and social care, through partnership, helping people achieve and maintain their best possible level of wellbeing and health. This provides an opportunity to deliver health and social care services through the Community Hub.

## **History and Heritage**

Portpatrick has a rich history and heritage. This provides opportunities for projects such as: Signposting to the historical information and links with existing resources. Providing information on walks and history trails.

#### **Economic Development**

As a Development Trust , PCDT aim to bring about long-tern sustainable social and economic development and regeneration in and around Portpatrick . We are working to combine community-led action with an enterprising approach. This means that we will be looking to maximise the benefit to local business when pro-

moting events or festivals and working with other event organisers in the wider area to bring benefits to Portpatrick. The very successful Skiffie Worlds in Stranraer was a case in point while we did get some benefit, a more co-ordinated response could have maximised the benefit to Portpatrick.

#### **Environmental Improvement**

Delivering environmental improvement is a key objective of PCDT. Interacting with existing and future initiatives including, operating as an information resource, about the marine and terrestrial local ecology. #### Working in partnership

An essential element of our approach is to work in partnership with other Development Trusts and Social Enterprise groups. # **Portpatrick Village Hall**

On 31st July PCDT submitted a Stage 2: Application for Asset Transfer for Community Asset Transfer for the Village Hall. This is the second stage in the process and allows us to present the request for Community Asset Transfer alongside our proposed development plan.



The need for both a community based development plan and for a suitable vehicle to bring Portpatrick Village Hall into community ownership was established over three years ago, when in November 2015, Dumfries and Galloway Council

called a public meeting to seek interest from the community for the management or asset transfer of the Village Hall.

#### **Governance and Management**

The Community Hub will be a separate project under PCDT. With its own Community Hub Management Team. This team will comprise the PCDT committee together with a volunteer group made up of active PCDT members and representatives of the partner groups and hall users. It is envisaged that the composition of this group will vary and change with time as community hub projects are developed and delivered. The Community Hub will be outward looking and will seek to engage with as wide a range of community interests as is possible.
